# UK Conditional Income Kick-out Plan (MS081)

The Plan has been structured to provide fixed quarterly income payments of 1.50 %, dependent on the performance of the FTSE 100 Index, over the six year term. The Plan has the potential to mature early (kick-out) from the second year and annually thereafter.

## Income Potential

On each of the 24 Observation Dates over the six year term, the Closing Level of the FTSE 100 Index will be compared with the Initial Index Level (the Closing Level of the Index on the Investment Start Date).
