

UK Semi-Annual Kick-out Plan (SG039)

The Plan provides the potential to receive an accumulated return of 7.75% p.a. depending on the performance of the FTSE 100 Index.

If, on an Observation Date, the FTSE 100 Index closes **at or above the Initial Index Level**, the Plan will end and the Initial Investment will be repaid, plus an accumulated return of 3.875% for each six month period that has elapsed (equivalent to 7.75% per annum) since the Investment Start Date.

If, however, the FTSE 100 Index closes **below the Initial Index Level** on an Observation Date, the Plan will continue to the next Observation Date.
