

UK Fixed Income Plan (CT088)

Structured Investments

The UK Fixed Income Plan has been structured to provide scheduled quarterly income payments of 1.67% over a four year term (equivalent to 6.68% per annum). The Plan does not have the ability to mature early at any time.

On each income payment date, a fixed payment of 1.67% will be made (equivalent to 6.68% per annum). These income payments are unconditional and do not depend on the performance of any underlying Index.

When the Plan has reached the full four year term, investors will lose a significant proportion of their Initial Investment if the Final Index Level is below 65% of its Initial Index Level on the Investment End Date.

The Plan will provide a total of 16 income payments.
