

Japan Step Down Kick-out Plan (HS470)

The Plan provides the potential to receive an accumulated return of 9.50% p.a. depending on the performance of the NIKKEI 225 Index.

If, on an Anniversary Date, the NIKKEI 225 Index closes **at or above the required kick-out level**, the Plan will end and the Initial Investment will be repaid, plus an accumulated return of 9.50% for each year that has elapsed since the Investment Start Date.

If, however, the NIKKEI 225 Index closes **below the required kick-out level** on an Anniversary Date, the Plan will continue to the next Anniversary Date.
