

# Japan Step Down Kick-out Plan (HS484)

If, on an Anniversary Date, the NIKKEI 225 Index closes **at or above the required kick-out level**, the Plan will end and the Initial Investment will be repaid, plus an accumulated return of 9.15% for each year that has elapsed since the Investment Start Date.
