

# Europe Annual Kick-out Plan (HS500)

The Plan provides the potential to receive an accumulated return of 9.25% p.a. depending on the performance of the EURO STOXX 50 Index.

If, on an Anniversary Date, the EURO STOXX 50 Index closes **at or above the Initial Index Level**, the Plan will end and the Initial Investment will be repaid, plus an accumulated return of 9.25% for each year that has elapsed since the Investment Start Date.

If, however, the EURO STOXX 50 Index closes **below the Initial Index Level** on an Anniversary Date, the Plan will continue to the next Anniversary Date.
