

Europe & US Defensive Step Down Kick-out Plan (HS598)

The Plan provides the potential to receive an accumulated return of 7.65% p.a. depending on the performance of the EURO STOXX 50 Index and the S&P 500 Index.

If, on an Anniversary Date, both the EURO STOXX 50 Index and the S&P 500 Index close **at or above their required kick-out levels**, the Plan will end and the Initial Investment will be repaid, plus an accumulated return of 7.65% for each year that has elapsed since the Investment Start Date.

If, however, the EURO STOXX 50 Index or the S&P 500 Index close **below their required kick-out levels** on an Anniversary Date, the Plan will continue to the next Anniversary Date.

Where the Plan has not matured early and runs to the full six year term, investors will lose a significant proportion of their Initial Investment if the Final Index Level of either Index is below 65% of its Initial Index Level on the Investment End Date.
