The Plan provides the potential to receive an accumulated return of 8.50% p.a. depending on the performance of the EURO STOXX 50 Index and the S&P 500 Index.

If, on an Anniversary Date, both the EURO STOXX 50 Index and the S&P 500 Index close **at or above their required kick-out levels**, the Plan will end and the Initial Investment will be repaid, plus an accumulated return of 8.50% for each year that has elapsed since the Investment Start Date.

If, however, the EURO STOXX 50 Index or the S&P 500 Index close **below their required kick-out levels** on an Anniversary Date, the Plan will continue to the next Anniversary Date.
