The FTSE Growth Kick-Out Plan aims to provide you with the potential to receive a fixed return of 30% capital growth after three years or a return equal to 150% of the rise in the FTSE<sup>TM</sup> 100 Index after six years.

Capital growth is dependent on the performance of the FTSE™ 100 Index between the start date of the investment and the third or sixth anniversary dates.

If, on the third anniversary, the FTSE<sup>™</sup> 100 Index is at the same level or higher than its initial level, the Plan will mature early and provide you with 30% capital growth.

If the Plan does not mature early it will continue through to the investment end date and provide you with capital growth equivalent to 150% of (1.5x) any rise in the FTSE<sup>TM</sup> 100 Index from its initial level.

The plan aims to return your capital in full at the end of the investment term. However, if the closing level of the Index is below 50% of the initial level on the investment end date, you could lose some or all of your initial investment. See page 6 for an explanation of this risk.

When you invest in the FTSE Growth Kick-Out Plan, you may receive **capital growth** of **30%** after three years depending on the performance of the FTSE<sup>TM</sup> 100 Index.

On the third anniversary date, the Closing Level of the FTSE™ 100 Index will be compared with the Initial Index Level.

If the Closing Level on that date is equal to or greater than the Initial Index Level, the Plan will mature early and you will receive back your Initial Capital plus 30% capital growth.

If, however, the Closing Level on that date is less than the Initial Index Level, the Plan will continue to the Investment End Date.



Page 6 describes in detail the effect that the Final Index Level (the Closing Level of the FTSE<sup>TM</sup> 100 Index on the Investment End Date) will have on your investment and the return of your capital.

The return you receive could be lower than if you invested directly in the shares of the companies of the Index. Additionally, your money is not invested directly in the shares of FTSE™ 100 companies and therefore you will not receive dividends from those companies.

If the Plan has not matured early, the **return of your capital** at the end of the term depends on the performance of the FTSE<sup>TM</sup> 100 Index.

If, after six years, the Index closes higher than the Initial Index Level, you will receive 100% of your capital, plus additional capital growth of 1.5% for every 1% the Final Index Level is above the Initial Index Level on the Investment End Date.

If, after six years, the Index closes at or below the Initial Index Level, but above 50% of the Initial Index Level you will receive 100% of your capital with no reduction, but no capital growth.

**If, however, the Index closes below 50% of the Initial Index Level** on the Investment End Date, your capital is at risk and there will be a capital reduction.

The capital reduction will be determined by the Final Index Level, which will be the Closing Level of the Index on the 31st March 2016. Capital will be reduced by 1% for every 1% the Final Index Level is below the Initial Index Level (or fraction thereof).



Irrespective of the performance of the FTSE™ 100 Index, your investment and the potential returns from the investment are at risk if the Issuer, HSBC Bank plc, were to fail (e.g. become insolvent).

Your money is not invested directly into the FTSE™ 100 Index. However, as the return of your investment is dependent on the performance of the FTSE™ 100 Index, it is important to understand what it is and how it could affect your money.

The FTSE<sup>TM</sup> 100 Index is a share index representing the performance of 100 of the UK's largest companies. It includes many household names such as GlaxoSmithKline, Tesco and Vodafone. It is a price index which means that it is based solely on share prices and does not take into account returns from dividends.

The graph below shows the FTSE™ 100 Index performance from 1984 to 5th February 2010. Past performance must not be seen as an indication of future performance.



Based on **an example** of the Closing Level of the FTSE<sup>TM</sup> 100 Index on the 5th February 2010 the Initial Index Level would be set at 5,060.92. Therefore, if the Final Index Level were to be below 2,530.46, you would receive back less than your Initial Capital. The last time the Index was below this level was the 7th October 1992.

This is only an example and in fact the Initial Index Level for the FTSE Growth Kick-Out Plan will not be set until the 31st March 2010, and therefore the 50% capital at risk level will not be set until this date.

You could lose some or all of your Initial Capital if the Final Index Level (the closing level of the FTSE™ 100 Index on the 31st March 2016) is below 50% of the Initial Index Level (the closing level of the FTSE™ 100 Index on the 31st March 2010).

It is important that you understand that the FTSE™ 100 Index can fall as well as rise, and that past performance must not be seen as an indication of future performance.

There are a number of ways you can invest in the Plan, some of the options allow you to increase tax-efficiency with careful planning. You should consult your Financial or Tax adviser for further details of your individual tax position.

#### **Direct investment**

It is Walker Crips' understanding that the returns you may receive on any direct investment are subject to Capital Gains Tax under present legislation. This means that you may be able to use your annual Capital Gains Tax exemption to reduce or eliminate the tax charge on any returns. You should be mindful of where you may have realised other investment gains, as the exemption applies to all of your gains over the whole tax year.

#### **Pension investment**

If you invest via a SIPP (Self Invested Personal Pension) or SSAS (Small Self Administered Scheme), investment returns within your pension are likely to be free of Income Tax and Capital Gains Tax. Before you invest, you should ensure that the terms of your scheme permit investments of this type.

#### ISA Investment

You can use your ISA allowance to invest from £5,000 to £7,200 for the 2009/2010 tax year, provided you have not opened a Stock and Shares ISA for the period 6th April 2009 to 5th April 2010. If you were born on or before 6th April 1960 and have reached 50 years of age, you can contribute a further £3,000, making a total allowance of £10,200. Please note if you have already invested in a Cash ISA for the 2009/2010 tax year your available allowance for a Stocks and Shares ISA will be reduced.

#### Other arrangements

The Plan is also eligible for most trust, corporate and charity investment. Before you invest, you should ensure that the terms or deeds under which the trust, company or charity was established allow investments of this type.

All information on taxation in this booklet is based on Walker Crips' understanding of UK tax legislation at the time of writing. Tax rules are subject to change and the value of tax reliefs will depend on your individual circumstances.

The FTSE Growth Kick-Out Plan is a structured investment plan managed and provided by Walker Crips. The investments underlying the plan are securities issued by HSBC Bank plc, a UK bank.

An investment in the Plan is an agreement with the Plan Manager, Walker Crips Structured Investments, to purchase an investment on your behalf and then hold and administer that investment on your behalf.

On the Investment Start Date, Walker Crips, as the Plan Manager, will use your money to acquire, on your behalf, securities which are specifically structured to match the investment objectives described in this brochure.


In the case of direct investments these securities will be warrants, for all other types of investment they will be Medium Term Notes. Warrants are a financial obligation of HSBC Bank plc that entitles you to the right of a specified return after a defined period of time. Medium Term Notes are a type of corporate bond, effectively a loan to the HSBC Bank plc, which they are obliged to repay.

Therefore, the return of your Capital and the capital growth payments as described in this brochure are subject to the continued solvency of the Issuer, HSBC Bank plc. In the event of the insolvency of HSBC Bank plc, investors could lose all or part of their investment, and any potential capital growth, regardless of the performance of the underlying index.

HSBC Bank plc has been rated "AA" by Standard & Poor's, at the time of publication. Standard & Poor's is an independent credit rating agency and uses a scale to denote creditworthiness ranging from "AAA" (highest) to "D" (lowest). Issuers within the "AA" rating band are described by Standard & Poor's as having very strong capacity to meet their financial commitments, differing from "AAA" issuers only to a small degree.

The Standard & Poor's rating is currently qualified with a "negative" outlook which means that a rating may be lowered. #### The Plan MAY be suitable for you if:

You will not need access to your Capital for six years.

You would like to potentially receive growth from your Capital.

You do not need income from your Capital.

You want the potential for a defined return.

You have a minimum of £5,000 to invest.

You are prepared to lose some or all of your Capital.

#### The Plan MAY NOT be suitable for you if:

You are not prepared to accept any risk to your Capital.

You do not have readily accessible spare cash for emergencies.

You need income from your Capital over the next six years.

You may need access to your capital before the Investment End Date in six years' time.

You want to add to your investment from time to time or at regular intervals.

You do not want your returns linked to stock market performance.

Your Capital is at risk and you could lose some or all of your Capital. Unless you understand these risks and are sure of the suitability of this investment for you, then you should take financial advice.

You should only invest in this Plan if you do not need access to your money for the full Investment Term of six years. Early withdrawal may result in loss of Capital.

The Plan is designed to provide you with a fixed level of return which is dependent on the performance of the FTSE<sup>TM</sup> 100 Index. In order to achieve this level of return, your Capital will be put at risk. If the Final Index Level Index is below 50% of the Initial Index Level you will lose some or all of your investment.

The Plan is subject to maximum growth potential and does not invest directly in the shares of any FTSE<sup>TM</sup> 100 companies and therefore does not receive dividends from those companies; as such the returns could be lower than if you invested directly in the shares of the Index.

If the institution issuing the underlying securities of the Plan were to fail (e.g. become insolvent), you could lose some or all of your investment. As with all similar structured investments, in the event of Issuer insolvency you will not have recourse to the Financial Services Compensation Scheme. It is you the investor who faces these risks rather than the Plan Manager, Walker Crips Structured Investments.

The Plan is not the same as a deposit account. A deposit account is considered a relatively safe way to invest and normally allows you ready access to your money. The FTSE Growth Kick-Out Plan gives you the potential to benefit from enhanced returns linked to the FTSE<sup>TM</sup> 100 Index; however your total return could be lower than you would have received in a deposit account.

#### Who is eligible to invest?

Anyone aged 18 or over who is resident and ordinarily resident in the UK for tax purposes may invest in the Plan. There is no upper age limit. Direct investments may be in joint names. The Plan is also available for UK trustees (including trustees of pension schemes), UK corporates and UK charities, where the terms of the arrangement permit investments of this type.

#### Can I change my mind?

Yes. When your Application Form is received, we will send you a cancellation notice. You will have 14 days from the date you receive this notice to return it. If this is before the Plan has purchased any securities, then you will receive your investment back in full with any accrued interest. If the Plan has purchased securities, then we will sell your holding and return the proceeds to you. You may get back less than you invested.

#### What is the early investment interest?

Walker Crips will pay interest on investments received up to the Investment Start Date from the date on which your cheque clears to and including the Investment Start Date. You will receive interest at a rate of 0.5% p.a. on your capital. This interest, rounded down to the nearest pound, will be added to your Initial Investment and the total amount invested in the Plan. Please note that the interest may be subject to tax, depending on your personal circumstances.

#### Can I transfer my investments?

It is possible to transfer your Investments to another plan manager or custodian. Should you wish to request a transfer you should ensure that the plan manager or custodian accepts transfers of this type. A charge of £90 will be levied by Walker Crips and you may also be charged by the new plan manager or custodian. If your Investment is held within an ISA you will need to transfer your Investment into another ISA plan to continue to benefit from the tax efficient status of the ISA.

#### Are you charging me for this investment?

The costs of setting up and administering your Plan have been allowed for in the calculation of returns the Plan is designed to pay. The anticipated charges for this Plan will be approximately 5% of your Initial Capital, which includes any commission payment to your Financial Adviser. If, however, you close your Plan early, an early withdrawal fee of £90 will be charged and you are likely to receive back less than you invested, especially in the early years of the Plan due to the effect of these charges.

#### What commissions are payable?

If you have a Financial Adviser, he or she will give you information about the cost of advice. Whether you receive advice or not, your Financial Adviser, if you have one, will receive a payment of up to 3% of your Initial Capital. The cost of this commission has been allowed for in the calculation of the returns from the Plan and no deductions will be made from your investment.

#### What happens if I die?

If you die before the Investment End Date, the Plan can be closed or transferred to another person. Your personal representatives should inform Walker Crips, and the Plan will be dealt with in accordance with their instructions. The Plan Manager will take instructions from the Trustees or Executors of the deceased with respect to disposals or cash withdrawals upon production of a Sealed Grant of Probate. Please see the section entitled "Can I withdraw my money?" for further details about how the withdrawal amount will be calculated.

#### Can I withdraw my money?

You should be aware that the Plan is designed to be held for the full six year Investment Term. However, if your circumstances change and you need access to your money, you may have to close your Plan. You can do this at any time but early encashment may result in loss of Capital, particularly in the early years of the Plan. Partial withdrawals from the Plan are not typically allowed but may be accepted at the discretion of the Plan Manager. If you need to close your Plan before the Investment End Date, you can instruct the Plan Manager to sell your holding. The Plan Manager would need to receive any such instruction in writing in order to arrange for the sale to be made. The amount you will receive will be determined by the market value of the underlying securities which are held on your behalf under the Plan. During the investment term this value may go up or down. A charge of £90 will be deducted should you close your Plan (or part of your Plan, if permitted) early.

#### What happens at the end of my investment?

Shortly before the Investment End Date, We will write to you regarding your options. You will normally receive financial settlement within 7 business days of the relevant Maturity Date provided that you complete and return the relevant documentation. Provision of proceeds from the Plan are dependent upon the Plan Manager's timely receipt of maturity proceeds from the Issuer. It may be possible to transfer the proceeds of the Plan into a new investment.

### How will I be kept informed of the progress of my investment?

When your application and payment are received, we will write to you with details of your Plan. We will send you statements twice a year until the Investment End Date so that you can keep track of your investment. #### How can I see a copy of the prospectus?

The Prospectus contains the full information and contractual terms for the securities. #### How do I make a complaint?



#### **Definitions:**

- (i) **'Account'** means your Walker Crips Account, or ISA Account holding your investment in the FTSE Growth Kick-Out Plan.
- (ii) **'Application Form'** means the FTSE Growth Kick-Out Plan application for an Account.
- (iii) 'Associated Companies' mean any agent with delegated authority under Section 20 of these Terms and Conditions.
- (iv) 'Calculation Agent' means the calculation agent assigned by the Issuer of the Investments in order to determine the maturity proceeds of the investment.
- (v) 'Closing Level' means the official daily closing level of the Index as published by the Index Sponsor in relation to each Scheduled Trading Day during the Investment Term.
- (vi) 'Dealing Date' means the 15th day in each calendar month, or if any such day is not a Scheduled Trading Day, the following day which is a Scheduled Trading Day.
- (vii) 'Direct Account' means any part of the FTSE Growth Kick-Out Plan which is not an ISA Account.
- (viii) 'Extraordinary Event' means an Extraordinary Event as determined by the Calculation Agent (acting in good faith and in a commercially reasonable manner) in accordance with the terms and conditions of the underlying securities.
- (ix) **'Final Index Level'** means the Closing Level of the FTSE<sup>TM</sup> 100 Index on the Investment End Date.

- (xiv) 'Index Sponsor' is FTSE International Limited, a UK incorporated company which calculates the Index and which is owned jointly by the London Stock Exchange and the Financial Times, and includes any successor or additional sponsor(s).
- (xv) 'Initial Capital' or 'Capital' means the money that you invest, plus any early investment interest that has been added.
- (xvi) **'Initial Investment'** means the money that you invest.

- (xvii) 'Initial Index Level' means the Closing Level of the FTSETM 100 Index on the Investment Start Date.
- (xviii) **'Investments'** means the securities the Plan Manager purchases and holds on your behalf under the Plan.
- (xix) **'Investment End Date'** means the 31st March 2016 or if such day is not a Scheduled Trading Day, the following day which is a Scheduled Trading Day.
- (xx) 'Investment Objective' means the objective of securing the return described in the brochure to which these Terms and Conditions are attached.
- (xxi) **'Investment Start Date'** means the 31st March 2010, or if such day is not a Scheduled Trading Day, the following day which is a Scheduled Trading Day.
- (xxii) **'Investment Term'** means the period from the Investment Start Date to the Investment End Date.
- (xxiii) 'Issuer' means HSBC Bank plc.

- 1.
