#### Objectives

This product is designed to provide a defined return when the product is redeemed (either at maturity or when redeemed early). It is possible for the product to be automatically redeemed early based on pre-defined conditions. The product is exposed to the credit risk of a basket of Reference Entities. Nominal Redemption Amount

The Default Amount for a Reference Entity affected by a Credit Event is calculated as 100% minus its Recovery Rate, multiplied by its basket weighting. In this scenario, you will suffer a total or partial loss of your invested amount.

Additional Information:

#### HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

#### Recommended Holding Period: 7 years 11 months 24 days, which corresponds to the product maturity.

Under normal market conditions, Société Générale or an entity of its group ensures a daily secondary market during the life of the product with a maximum bid-offer spread of 1.00%. If you want to sell this product before the Maturity Date, the price of the product will depend on market parameters at the time you wish to sell and you may sustain a partial or total capital loss. In unusual market condition, the resale of the product may be temporarily suspended.
