Type

This product is a secured and limited recourse debt instrument governed by English law. This product tracks the value of a security which is linked to the Underlying.

Objectives

This product is designed to provide a defined return when the product is redeemed (either at maturity or when redeemed early). It is possible for the product to be automatically redeemed early based on pre-defined conditions. If the product is not redeemed early, both the return and the capital redemption amount will be linked to the performance of the Reference Underlying. The product is exposed to the credit risk of a basket of Reference Entities. These Reference Entities and their respective basket weightings are: Barclays plc (1/3), HSBC HOLDINGS plc (1/3) and LLOYDS BANKING GROUP PLC (1/3). Your capital will be fully at risk when investing in this product.

Automatic Early Redemption:

On each Early Redemption Observation Date, if the Level of the Reference Underlying is at or above the Early Redemption Barrier, the product will be redeemed early, you will receive:

The Nominal Redemption Amount multiplied by

100% of the Nominal Value plus the Early Redemption Return multiplied by the number of years the product has elapsed since inception.

Final Redemption:

On the Maturity Date, provided that the product has not been redeemed early, you will receive a final redemption amount.

If the Final Level of the Reference Underlying is at or above the Final Barrier, you will receive:

The Nominal Redemption Amount multiplied by

100% of the Nominal Value plus the Final Return.

If the Final Level of the Reference Underlying is below the Final Barrier and at or above the Capital Barrier, you will receive:

The Nominal Redemption Amount multiplied by

100% of the Nominal Value

Otherwise, you will receive the

The Nominal Redemption Amount multiplied by

the Final Level of the Reference Underlying multiplied by the Nominal Value. In this scenario, you will suffer a partial or total loss of your invested amount.

Nominal Redemption Amount

In the case of a Credit Event on any Reference Entity during the product's lifetime, the Nominal Redemption Amount will be reduced by a percentage equal to the Default Amount for each Reference Entity that has been affected by a Credit Event.

The Default Amount for a Reference Entity affected by a Credit Event is calculated as 100% minus its Recovery Rate, multiplied by its basket weighting. In this scenario, you will suffer a total or partial loss of your invested amount.

If none of the References Entities is impacted by a Credit Event, the Nominal Redemption Amount is equal to 100%

Additional Information:

The Level of each Reference Underlying corresponds to its value expressed as a percentage of its Initial Value.

The Initial Value of each Reference Underlying is its value observed on the Initial Observation Date.

On each observation date, the Worst Level is the worst Level of the 2 Reference Underlyings.

The Level of the Reference Underlying is the Worst Levels calculated on the Early Redemption Observation Dates and the Final Observation Date.

Returns are expressed as a percentage of the nominal value

Certain extraordinary events that are not described above can occur, which could affect the product, the related underlying(s), the product issuer or the Reference Entities. These may result in adjustments being made to the product's terms and, in certain cases, may lead to the early termination of the product and could result in losses on your investment. The product is available through a public offering during the applicable offering period in the United Kingdom.

A Credit Event occurs when an entity becomes insolvent, defaults on its payment obligations, experiences a restructuring of its debt obligations in a manner that is detrimental to creditors, or is subject to government intervention.

The term "Credit Event" is defined in the 2014 ISDA Credit Derivatives Definitions, as published by the International Swaps and Derivatives Association, Inc. ("ISDA") (www.isda.org). The Recovery Rate is generally defined as the value of a security following a default. More precisely it is the amount of principal and interest on a defaulted debt instrument that can be recovered, expressed as a percentage of its face value. The Recovery Rate is determined by the process outlined by The International Swaps and Derivatives Association (ISDA) Committee (www.isda.org).

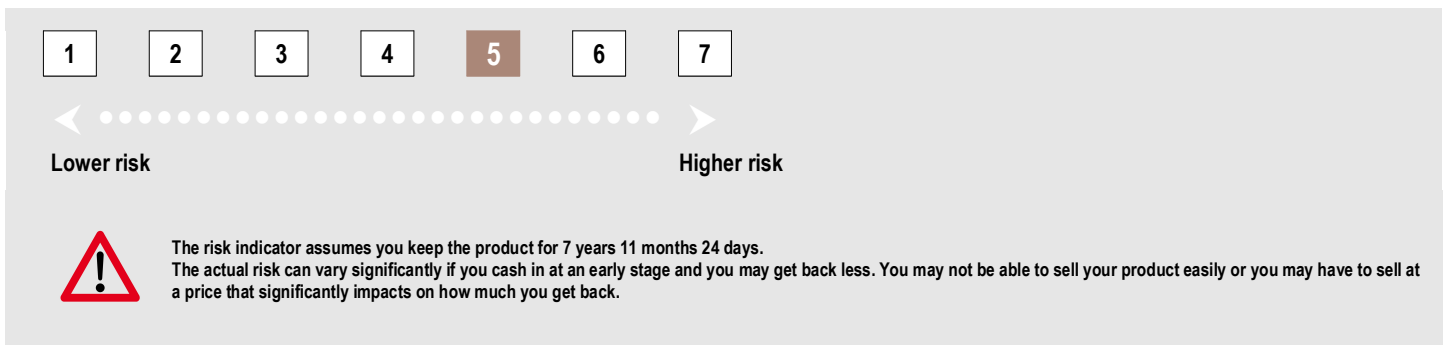

WHAT ARE THE COSTS?

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended Holding Period: 7 years 11 months 24 days, which corresponds to the product maturity.

Under normal market conditions, Société Générale or an entity of its group ensures a daily secondary market during the life of the product with a maximum bid-offer spread of 1.00%. If you want to sell this product before the Maturity Date, the price of the product will depend on market parameters at the time you wish to sell and you may sustain a partial or total capital loss. In unusual market condition, the resale of the product may be temporarily suspended.
